A copy of the audited financial accounts for the period 1 July 2023 to 30 June 2024 has been made available to all members in the 2024 Annual Report.

In the auditor's opinion, the financial report presents fairly and accurately the College's finances as of 30 June 2023, and of its financial performance and cash flows for the year. The auditor believes the accounts meet the requirements of the Corporations Act 2001 and the Australian Accounting Standards (including Australian Accounting Interpretations).

- Audited surplus of \$681,000
- Equity of \$8.78m as of 30 June 2024
- The College will see income and surpluses stabilise as education courses stabilises to
  a more regular level
- Education bookings, and FIPC specifically, remained our strongest revenue stream.
- Interest income was \$272k through term deposits
- Overall income decreased from \$4.09M to \$3.5M
